REACH, EC Regulation 1907/2006 SVHC (Candidate List of Substances of Very High Concern)

Dear Sirs,

Further to your above mentioned letter on the subject of the "Candidate List", we wish to inform you as follows.

According to article 59 (1, 10) of the regulation (EC) No 1907/2006 (REACH), an updated candidate list **(status 01/19/2021** <u>www.echa.europa.eu/de/candidate-list-table</u>) was published.

Our articles made of machining steel 1.0718 (11SMnPb30), heat-treated steel 1.0502 (C35Pb+C), brass (CW608N, CW614N) and aluminium (EN AW-2011) contain the following substances of the current candidate list in oncentrations above 0.1 % weight by weight (w/w):

Lead (CAS number: 7439-92-1, EC number: 231-100-4)

Our articles with galvanized yellow chromated surface contain the following substances of the current Annex XIV of the REACH Regulation in concentrations above 0.1 % weight by weight (w/w):

Chromium trioxide (CAS number: 1333-82-0, EC number: 215-607-8)

According to our current understanding and based on the information of our subcontractors, our coatings either do not contain the substances shown in the Candidate List or do not exceed the limiting value of 0.1 % weight by weight (w/w).

Insofar as any of the items we deliver to you contains any SVHC substance set out in the current candidate list in a quantity of > 0.1 percent by weight, we will inform you, in the future, by including a relevant note on our delivery notes, order confirmations, and invoices.
